Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 16,000, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 2330100303010002 (Dharauti Khata) at Rashtriya Banijya Bank, Aiselukharka Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
